CLUBHOUSE MUST BE VACANT BY EXACT END TIME OR A \$50.00 FEE WILL BE ASSESSED. ADDITIONAL \$50.00 FEES INCUR AT FIFTEEN MINUTE INCREMENTS.

- All garbage must be taken out to the dumpster.
- All furniture must be returned to the original placement as shown on the refrigerator.
- Children must be supervised everywhere in the facility; screaming, running or disruptive behavior is not permitted.
- Once booked, cancelations are not refundable.
- Helium balloons, Scotch tape, tacks & nails are not permitted.
- The unit owner is responsible for all guests including pool guests.
- Music must be kept at a volume to not disturb other patrons, neighbors or staff.
- Report any damage, accidents or injuries to staff.
- Only people with disabilities may use the handicap bathrooms & elevator.
- A final walk-through with staff is required after the event & the host must sign off.
- The security deposit check will be returned by mail after management's inspection.

Pool Party Rules

INITIAL NEXT TO RULES IN BOLD & SIGN AT THE BOTTOM

_____ I will introduce myself to the Lifeguard(s) before the start of our swim time.

_____ Lifeguards on duty have full authority for pool related areas.

_____ My guests will wear official swim garments: lined lycra, nylon or polyester intended for swimming.

_____ Children not potty trained *must* wear swim diapers.

_____ One adult must be on the pool deck for every four children ten & under.

_____ I will ensure that my guests adhere to pool rules, including:

- No hanging, pulling, or moving the rope without permission of the lifeguard.
- No hanging on the metal railings.
- No running, rough housing, dunking, pushing, or chicken fighting.
- Diving is allowed in *deep end only*, no front or back flips.
- Foam or inflatable balls only.
- No food, drinks, alcohol, or drugs on the pool deck.
- No nudity or revealing swim wear.
- No photography or videography of anyone outside your group.

_____ When the pool party ends, pool area & locker rooms must be free of items & chairs, lawn chairs & tables returned.
